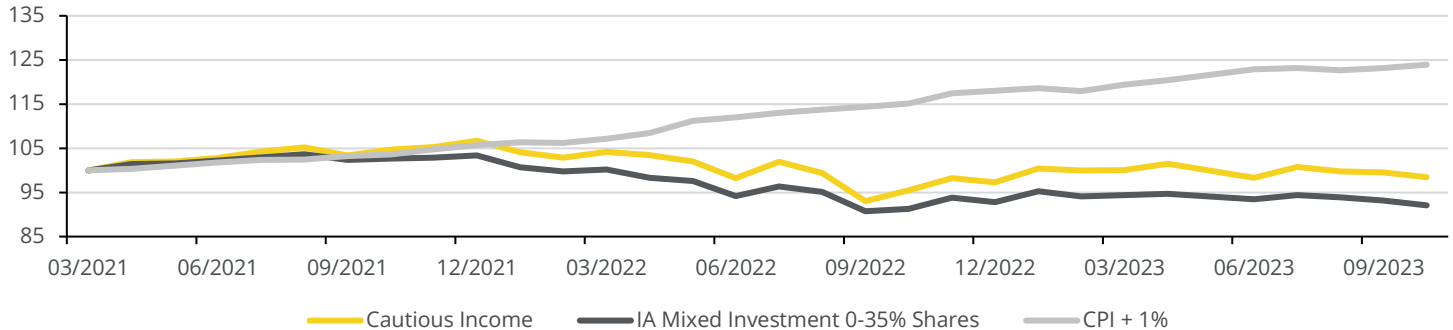


### Cautious Income Portfolio and CPI Target Performance Since Inception

#### Investment Philosophy

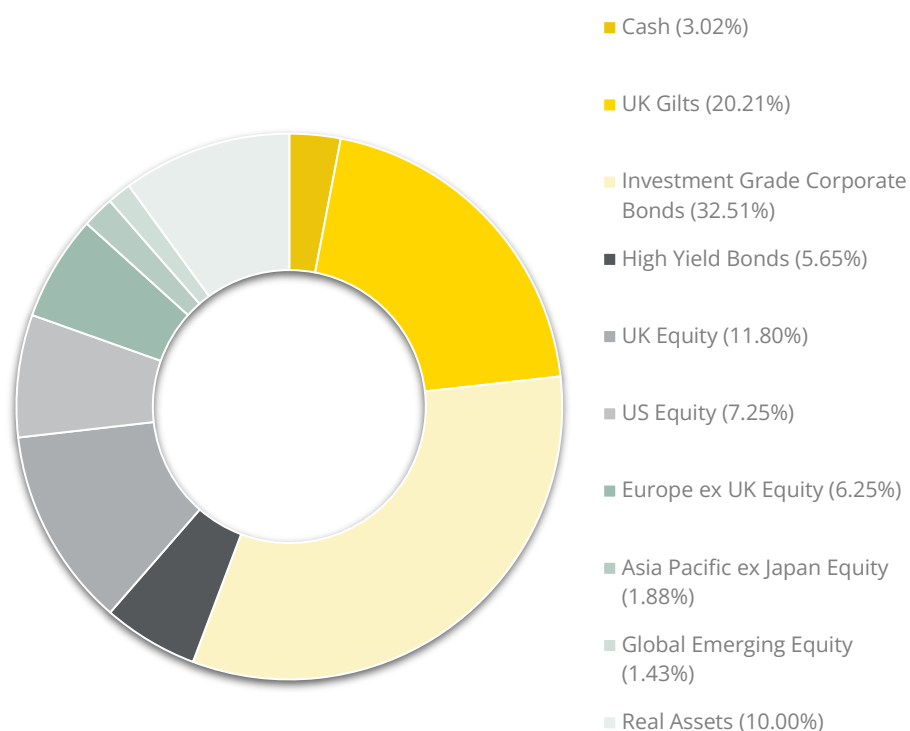

The Cautious Portfolio aims to deliver a return of UK CPI plus 1% over rolling 5 years.

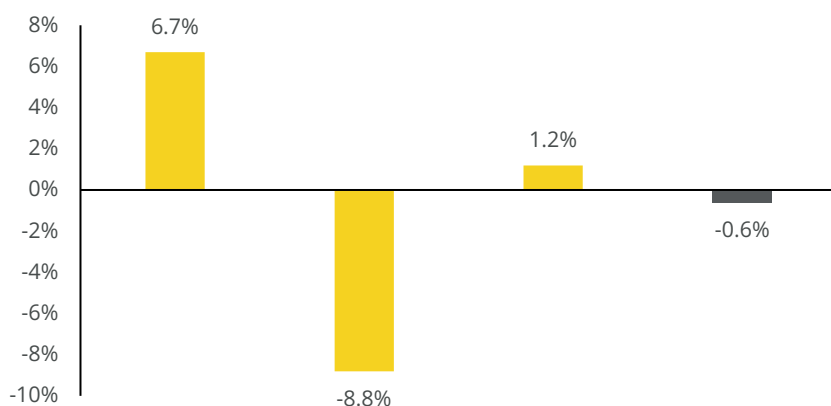
