

Investment Philosophy

At One Four Nine Portfolio Management (OFNPM) we fundamentally believe that investors are loss averse, not risk averse. Our investment philosophy is built around 3 principles:

Each Model Portfolio aims to achieve its objectives through investment in a global multi-asset portfolio consisting of equities, bond, commercial property, and other asset classes. Exposure is primarily gained through collective investment schemes (unit trusts, OEICS, investment trusts, ETFs).

Risk Profile and Objective

The Passive Balanced Portfolio aims to deliver a return of UK CPI plus 2% over rolling 5 years.

The Passive Balanced Portfolio is appropriate for an investor who is comfortable with moderate volatility of returns and having up to around 60% of their portfolio in equities. You are comfortable that in 1 year out of 20 your portfolio could fall by more than 15% in any one year. Volatility is typically between 7% and 12% and investors should have a minimum time horizon of 5 years.
