

Defensive Risk Profile and Objective

The Defensive Portfolio aims to deliver a return of UK CPI over rolling 5 years.

You are comfortable that in **1 year out of 20** your portfolio could **fall by more than 5% in any one year**. Volatility is typically between 4% and 7%.


